Be it remembered that on the several days mentioned in the respective captions hereunder written Eliza Anne Holley of Brandiston in the County of Norfolk Spinster and Windham Hunt Holley of Oakhamptom in the County of Devon Esq Copyhold tenants of the said Manor came before the several Deputy Stewards of this Manor whose names are respectively subscribed to the same captions and thereupon in pursuance of a covenant for that purpose contained in a certain Indenture dated the 23rd day of October 1880 and made between the said E A Holley and W H Holley of the one part James Hunt Holley of the second part and Richard Carol Barton of the other part and in consideration of the sum of £5 sterling the apportioned common money on sale of the copyhold heredita hereinafter expressed to be surrendered to the said E A Holley and W H Holley paid by the said R C Barton as in the said Indenture expressed the receipt thereof is by the said Indenture acknowledged and the 10CNR stamp applicable to which sum is expressed on this Memorandum of Surrender as required by Law. Did out of Court at the request and by the direction of said R C Barton testified by his signature at the foot thereof and in common of the sum of £5 sterling paid by the said R C Barton upon the passing the surrender hereinafter expressed the receipt thereof is hereby and by the receipt hereunder written acknowledged Surrender out of their and each of their hands into the hands of the Lord of the said Manor by the hands and acceptance of the said Deputy Stewards by the Rod according to the custom of the said Manor. All that piece or parcel of Lands containing 20 perches more or less formerly parcel of 17.1.25 in Hackford lying on the west side thereof as the same is part of an inclosure containing 2.2.33 and is bounded on the public road from Bawdeswell to Reepham north and by the residue of the said inclosure east, south and west and is holder of the said Manor by Copy of Court Roll. To which premises John Leeds a former owner thereof was admitted tenant at a Court held for the said Manor on the 3rd day of December 1810 by virtue of the Awards of the Common named in an act of Parliament for enclosing lands in the parishes of Whitwell and Hackford and revon & revons, remdr & remdrs yearly and other remb issues and profits thereof. And all the Estate right title interest inheritance use must properly possession claim and demand of in to from or out of the same. To the use and behoof of Edward Silva of 17 at Pembridge Square, Bayswater in the County of Middlesex. Esq and John Pearman of Drayton House, Lavender Hill in the County of Surrey. Gente their heirs and assigns for ever as tenants in common and not as joint tenants at the Will of the Lord according to the custom of the said Manor.
